Contributions to the state and Federal PACs and Small Donor Committee are not tax deductible for federal income tax purposes. Federal law requires us to use our best efforts to collect and report the name, mailing address, occupation and name of employer of those individuals whose contribution exceed \$200 in an election cycle. State law requires us to collect the similar information from individuals as does the Federal law -those who contribute \$20 or more in an election cycle - name, address and occupation, and name of employer for individuals whose contributions exceed \$200 (cycle equals a two year period between Federal elections). Corporate contributions are prohibited. Contributions to the PACs are used to support credit union friendly candidates. Contributions are strictly voluntary. You have the right to refuse to contribute without any reprisal.
